## Opportunities

- ▶ Leverage technology to:
  - ▶ Streamline workflow processes
  - ▶ Develop staffing guidelines based on patient needs
  - ▶ Automate manual processes
  - ▶ Utilize clinical decision support tools to make decisions that impact nursing care, quality and patient outcomes

## FHIR

- ▶ Fast Healthcare Interoperability Resource
- ▶ Actionable data
- ▶ Exchange specific pieces of data to make real-time healthcare decisions

## Staffing Based Acuity

- ▶ Patient centered approach to staffing
- ▶ Skill mix analysis (RN/LPN/CAN/MA) input from advisory board
- ▶ Utilizing staffing resources appropriately
- ▶ Data to support budgeting and FTE decisions

## Nursing Workflows

- ▶ More than the automation of manual processes
- ▶ Enhance workflows to increase communication throughout the continuum of care.
- ▶ Capturing clinical data

## Nursing Informaticians

- ▶ Transform healthcare by:
  - ▶ Analyzing
  - ▶ Designing
  - ▶ Implementing
  - ▶ Evaluating
